In the latter case, the organiser is liable for any foreseeable and typically ensuing damage. The organiser is fully liable for damages in the event of loss of life, personal injury or injury to health caused purposefully or negligently.
- 2 The organiser reserves the right to deny admission the show grounds with good reason.
- 3 Audio, photo, film or video recording in the sponsor area is strictly prohibited. Malpractice can be brought to criminal prosecution.
